ARTICLE 1 DENOMINATION

IT IS FOUNDED BETWEEN THE PERSONS ADHERING TO THE PRESENT STATUTES AN
ASSOCIATION WITH A NON PROFIT PURPOSE GOVERNED BY THE LAW OF JULY 1ST 1901 AND
ITS IMPLEMENTING TEXTS BEARING THE NAME:
O.R. WORLD ASSOCIATION

ARTICLE 2 PURPOSE

THE PURPOSE OF THE ASSOCIATION IS TO BRING TOGETHER ENTHUSIASTS OF
CONTEMPORARY POP MUSIC AND NORDIC CULTURE THROUGH CULTURAL CREATIVE AND
COMMUNITY ACTIONS.

ITS MISSIONS INCLUDE IN PARTICULAR:

THE FEDERATION OF FANS AROUND COLLABORATIVE PROJECTS,

OFFER PUBLICATIONS OR ASSOCIATIVE ITEMS WITH A NON PROFIT PURPOSE,
COLLABORATE WITH ARTISTS CREATORS PARTNERS OR INSTITUTIONS SHARING SIMILAR
CULTURAL VALUES,

PROMOTE GOOD PRACTICES REGARDING RESPECT FOR COPYRIGHT AND IMAGE RIGHTS.

ARTICLE 6 COMPOSITION

THE ASSOCIATION IS COMPOSED OF:

ACTIVE MEMBERS NATURAL OR LEGAL PERSONS UP TO DATE WITH THEIR MEMBERSHIP FEE
BENEFACTOR MEMBERS PERSONS PROVIDING FINANCIAL OR MATERIAL SUPPORT
MINOR MEMBERS SUBJECT TO PARENTAL AUTHORIZATION ACCORDING TO THE TERMS
DEFINED IN THE INTERNAL REGULATIONS

ARTICLE 6 BIS LOSS OF MEMBERSHIP STATUS

MEMBERSHIP STATUS IS LOST BY:

VOLUNTARY RESIGNATION SENT IN WRITING TO THE EXECUTIVE BOARD

AUTOMATIC REMOVAL IN CASE OF NON RENEWAL OF THE MEMBERSHIP FEE WITHIN THREE MONTHS AFTER REMINDER DEATH OF THE MEMBER

EXCLUSION DECIDED BY THE EXECUTIVE BOARD FOR SERIOUS REASON BEHAVIOR CONTRARY TO THE VALUES OF THE ASSOCIATION NON COMPLIANCE WITH THE INTERNAL REGULATIONS UNAUTHORIZED DISSEMINATION OF PROTECTED CONTENT DISCRIMINATORY OR HARMFUL STATEMENTS.

THE CONCERNED MEMBER IS INFORMED AND MAY PRESENT OBSERVATIONS BEFORE FINAL DECISION.

ARTICLE 7 MEMBERSHIP FEE

THE AMOUNT OF THE ANNUAL MEMBERSHIP FEE IS SET BY THE GENERAL ASSEMBLY UPON PROPOSAL OF THE EXECUTIVE BOARD.

IT GIVES ACCESS TO THE BENEFITS DEFINED IN THE INTERNAL REGULATIONS MEMBERSHIP CARD CONTESTS PARTICIPATION IN CREATIVE WORKSHOPS ETC.

ARTICLE 8 RESOURCES

THE RESOURCES OF THE ASSOCIATION INCLUDE:

MEMBERSHIP FEES DONATIONS AND PUBLIC OR PRIVATE SUBSIDIES

INCOME FROM ASSOCIATIVE SALES OR EVENTS CROWDFUNDING

ANY OTHER RESOURCE AUTHORIZED BY LAW

ARTICLE 9 INTERNATIONAL OPERATION

THE ASSOCIATION ALTHOUGH ESTABLISHED IN FRANCE MAY WELCOME MEMBERS RESIDING OUTSIDE FRANCE.

SPECIFIC ARRANGEMENTS SHIPPING FEES PARTICIPATION IN ACTIVITIES TRANSLATION ARE DEFINED BY THE EXECUTIVE BOARD AND SPECIFIED IN THE INTERNAL REGULATIONS.

ARTICLE 10 ADMINISTRATION

THE ASSOCIATION IS ADMINISTERED BY AN EXECUTIVE BOARD COMPOSED AT
MINIMUM OF:

A PRESIDENT

A SECRETARY

A TREASURER

MEMBERS OF THE EXECUTIVE BOARD ARE ELECTED FOR A TWO YEAR RENEWABLE
TERM BY THE GENERAL ASSEMBLY.

ARTICLE 11 GENERAL ASSEMBLIES

THE ORDINARY GENERAL ASSEMBLY MEETS AT LEAST ONCE A YEAR.

IT IS CONVENED BY THE EXECUTIVE BOARD AND IS RESPONSIBLE FOR:

APPROVING MORAL AND FINANCIAL REPORTS

ELECTING OR RENEWING MEMBERS OF THE EXECUTIVE BOARD

DELIBERATING ON PROJECTS ORIENTATIONS AND STATUTORY AMENDMENTS

THE GENERAL ASSEMBLY MAY VALIDLY DELIBERATE ONLY IF AT LEAST TWENTY FIVE
PERCENT OF THE MEMBERS OF THE ASSOCIATION ARE PRESENT OR REPRESENTED.
IF THIS QUORUM IS NOT REACHED A SECOND CONVOCATION IS SENT WITHIN FIFTEEN
DAYS.

DURING THIS SECOND MEETING THE GENERAL ASSEMBLY MAY VALIDLY DELIBERATE
REGARDLESS OF THE NUMBER OF MEMBERS PRESENT OR REPRESENTED.

DECISIONS ARE TAKEN BY MAJORITY OF MEMBERS PRESENT OR REPRESENTED.

THE EXTRAORDINARY GENERAL ASSEMBLY TAKES PLACE UNDER THE SAME
CONDITIONS BUT REQUIRES THAT AT LEAST FIFTY PERCENT OF THE MEMBERS OF THE
ASSOCIATION ARE PRESENT OR REPRESENTED.

CONVOCATION IS CARRIED OUT ELECTRONICALLY THREE WEEKS BEFORE THE DATE OF
THE GENERAL ASSEMBLY.

ARTICLE 11 BIS REMOTE GENERAL ASSEMBLIES

GENERAL ASSEMBLIES ORDINARY OR EXTRAORDINARY MAY BE HELD IN PERSON REMOTELY OR IN HYBRID MODE ACCORDING TO THE TERMS DEFINED BY THE EXECUTIVE BOARD.

REMOTE HOLDING MAY BE CARRIED OUT BY ANY ELECTRONIC COMMUNICATION MEANS ALLOWING IDENTIFICATION OF MEMBERS EFFECTIVE PARTICIPATION IN DEBATES AND VOTING ON RESOLUTIONS VIDEOCONFERENCE AUDIOCONFERENCE SECURE PLATFORM ETC.

CONVOICATIONS MUST SPECIFY THE TECHNICAL CONNECTION AND ACCESS PROCEDURES.

MEMBERS PARTICIPATING REMOTELY ARE DEEMED PRESENT FOR QUORUM AND MAJORITY CALCULATIONS.

IN THE EVENT OF TECHNICAL DIFFICULTY PREVENTING PARTICIPATION A MEMBER MAY GRANT PROXY TO ANOTHER MEMBER UNDER THE CONDITIONS PROVIDED FOR BY THE PRESENT STATUTES.

ARTICLE 12 INTERNAL REGULATIONS

INTERNAL REGULATIONS ARE ESTABLISHED BY THE EXECUTIVE BOARD AND VALIDATED BY THE GENERAL ASSEMBLY.

THEY SPECIFY PRACTICAL OPERATING PROCEDURES RIGHTS AND DUTIES OF MEMBERS RULES FOR PARTICIPATION IN ACTIVITIES AND COMPLEMENT THE PRESENT STATUTES.

ARTICLE 13 AMENDMENT OF THE STATUTES

THE STATUTES MAY BE AMENDED BY THE EXTRAORDINARY GENERAL ASSEMBLY UPON PROPOSAL OF THE EXECUTIVE BOARD OR ONE THIRD OF THE MEMBERS. DECISIONS ARE TAKEN BY MAJORITY OF MEMBERS PRESENT OR REPRESENTED.

ARTICLE 13 AMENDMENT OF THE STATUTES

THE STATUTES MAY BE AMENDED BY THE EXTRAORDINARY GENERAL ASSEMBLY UPON PROPOSAL OF THE EXECUTIVE BOARD OR ONE THIRD OF THE MEMBERS. DECISIONS ARE TAKEN BY MAJORITY OF MEMBERS PRESENT OR REPRESENTED.

ARTICLE 14 COPYRIGHT AND IMAGE RIGHTS

THE ASSOCIATION UNDERTAKES TO RESPECT COPYRIGHT RELATED RIGHTS AND IMAGE RIGHTS OF ANY PERSON OR ENTITY.

IT PROHIBITS ANY UNAUTHORIZED DISSEMINATION REPRODUCTION OR USE OF PROTECTED CONTENT MUSIC LYRICS VIDEOS PHOTOGRAPHS VISUALS.

ANY REFERENCE TO AN ARTIST OR WORK IS MADE WITHIN AN INFORMATIONAL CRITICAL OR CULTURAL FRAMEWORK WITHOUT COMMERCIAL USE.

MEMBERS UNDERTAKE TO RESPECT THESE RULES IN ALL THEIR ACTIVITIES.

ARTICLE 15 DISSOLUTION

DISSOLUTION OF THE ASSOCIATION MAY ONLY BE DECIDED BY AN EXTRAORDINARY GENERAL ASSEMBLY CONVENED FOR THIS PURPOSE.

IN THE EVENT OF DISSOLUTION THE NET ASSETS SHALL BE ALLOCATED TO A CHARITABLE ORGANIZATION OR AN ASSOCIATION PURSUING SIMILAR OBJECTIVES DESIGNATED BY THE ASSEMBLY.
